REAS OF PRACTICE

Class Actions

Class action and multidistrict litigation is a mainstay of our practice. The firm's practice in multidistrict litigation (MDL) class actions began in 1972 with the representation of victims of the crash of Eastern Airlines Flight 401 in the Florida Everglades. Partner Aaron Podhurst was appointed to serve as the chairman of the plaintiffs' executive committee among the lawyers representing hundreds of cases in the matter. The case was resolved within a year – a rarity for multidistrict litigation – and served as a stepping-stone to the firm's success.

Our attorneys have served as court-appointed lead or liaison counsel in numerous major class actions, including aviation, securities litigation, investor fraud cases, pharmaceutical, consumer, healthcare and insurance litigation. From its inception, the firm has cultivated the appellate and class action practices of not only the firm's trial lawyers, but also representational partnerships with other lawyers throughout the nation.

Our firm members practice in many state and federal appellate courts, including the United States Supreme Court. The firm's practice serves clients residing or based domestically throughout the United States as well as those around the world.

Podhurst Orseck's attorneys are respected nationally and internationally for their involvement and results in multidistrict class action litigation representation. General Tort Practice Concentrating in Automobile Negligence, Product Liability and Medical Malpractice Litigation

Since its inception, the foundation of the firm's trial practice has been general tort law. Our experience runs the gamut of such cases, from complex products liability, to business-related torts to automobile liability. Literally thousands of general negligence and product liability cases of all sorts have been prepared, negotiated, and either settled or tried by the members of this firm.

An abbreviated listing of the types of cases handled would include all types of product liability and general negligence cases ranging from chemical spills to use of dangerous pesticides.

The firm was successful in handling a case involving the improper discharge of elemental mercury causing permanent physical injuries and ecological damages to residents of an entire municipality and in another case involving the use of a pesticide named 1,2 Dibromo-3-chloropropane ("DBCP") known to cause sterility in humans due to its highly toxic properties.

Similarly, the firm also has successfully handled numerous complex medical, legal, accounting, architectural and engineering malpractice claims.

Aviation Litigation

A major emphasis within the firm's general tort practice is aviation litigation. The firm is recognized as one of the premier plaintiffs' aviation law firms in the world. We believe that the firm has handled more plaintiffs' aviation cases than any other firm in the southeastern United States. The firm has represented multiple victims of over 40 major air disasters over the past fifty years. In addition, the firm has handled in excess of 100 small or light plane crashes involving private, non-commercial airplanes.

Members of this firm have chaired the Aviation and Space Committee of the Tort & Insurance Practice Section of the American Bar Association; the Aviation Committee of the Association of Trial Lawyers of America; the Aviation Committee of The Florida Bar; and the Aviation Advisory Committee of the Association of Trial Lawyers of America. We have been guest lecturers at more than 100 aviation law seminars, including the American Bar Association's National Institutes on Aviation and Lloyds of London's international meetings; at Florida Bar, The Florida Justice Association, and American Association for Justice seminars. Firm members have been court appointed as lead counsel in federal aviation multidistrict litigation proceedings; and have tried or settled numerous aviation accident cases. Two of our partners are licensed pilots. One served as a naval aviator in the United States Navy from 1965 to 1971, and flew 150 combat missions in Southeast Asia in carrier-based A-7 aircraft. He also worked as an aircraft systems safety engineer and accident investigator for the Vought Aeronautics Division of LTV Aerospace Corporation between his service in the Navy and attending law school.

This firm is proud to have played a prominent role in the development of aviation jurisprudence over the past fifty years. It has acquired in this context specialized expertise on such complex questions as jurisdiction, venue, forum non conveniens, and choice of law. Members of this firm have appeared before every local federal and state court, the Eleventh Circuit Court of Appeals, the Florida and U.S. Supreme Courts, the Panel on Multi-District Litigation and the U.S. Congress on behalf of aviation plaintiffs.

Commercial Litigation

Nearly fifty percent of this firm's trial and appellate litigation involves the resolution of corporate and commercial disputes. Our practice varies from the most complex commercial cases to straight forward contract disputes. The firm's commercial clientele includes Fortune 500 companies, small and middle-sized companies, and private individuals.

The firm handles commercial cases under both hourly and contingency arrangements. We employ experienced paralegal and support staff to assist the lawyers in order to ensure cost efficient handling of these cases. In addition, the firm has developed and implemented an advanced, computerized litigation support system to deal with the voluminous documentation usually associated with complex commercial litigation.

Appellate Practice

Two of our partners--Joel Eaton and Stephen F. Rosenthal--devote their practices exclusively to appellate litigation and complex trial-level motions, handling all in-house matters and referrals from attorneys and clients all over the United States. They practice primarily in the United States Court of Appeals for the Eleventh Circuit, the Florida Supreme Court, and the intermediate Florida District Courts of Appeal, but they also handle appellate litigation elsewhere in the United States. Mr. Eaton has also argued several cases in the United States Supreme Court. Their practice mirrors the substantive diversity of the firm as a whole, and includes plaintiffs' personal-injury, medical malpractice, and wrongful-death cases, including aviation-related matters and commercial matters of all types.

White Collar Criminal Investigations and Litigation

Aaron Podhurst has been a distinguished trial lawyer for more than fifty years. He received his B.A. from the University of Michigan and his Juris Doctorate Degree from Columbia University, where he was a Harland Fiske Stone Scholar. Aaron is admitted to the Florida and New York Bars.

Aaron's distinguished career has brought him honors and offices from virtually every major legal organization, including the presidencies of the International Academy of Trial Lawyers and Academy of Florida Trial Lawyers, fellowship in the American College of Trial Lawyers, member of Board of Governors of Association of Trial Lawyers of America, membership in the International Society of Barristers and the Inner Circle of Advocates, member of the Cuban American Bar Association and chairmanship of various aviation committees of the American Bar Association, Association of Trial Lawyers of America and the Academy of Florida Trial Lawyers.

Although Aaron made his reputation as one of the nation's premiere plaintiff's aviation lawyers, and continues to hold that status, he has guided the firm in recent years to its status as one of the major commercial litigation firms in South Florida. ROBERT ORSECK (1934-1978)

At the time of his death, Robert Orseck was the firm's appellate attorney. He inspired both friendship and respect, and his loss is felt personally and painfully by all who knew him.

In the fifteen years in which he practiced, Bobby established himself as the premier appellate practitioner in Florida. Although his services were sought by a large variety of clients, he chose to devote his career primarily to the representation of tort plaintiffs, and he often appeared on behalf of the Academy of Florida Trial Lawyers as amicus curiae in major appeals affecting the rights of accident victims. His deep sense of compassion for the rights and lives of others, combined with his legal genius and abounding energy, produced an impressive anthology of case law containing important decisions familiar to every trial and appellate attorney in Florida. They include *Holl v. Talcott*, *West v. Caterpillar Tractor Co., Inc.*, *Metropolitan Dade County v. Dillon*, *Compania Dominicana de Aviacion v. Knapp*, *Gates v. Foley*, *Auburn Machine Works Co. v. Jones*, *Lincenberg v. Issen*, *Mathews v. Ranger*, *Wood v. Camp*, and *Markert v. Johnson*. The Southern Reporter and Federal Reporter contain over 350 reported decisions in which Bobby appeared as counsel.

Many memorials have been and will be dedicated to Bobby Orseck. His presence will continue to be felt in the appellate process for many years to come, because of his intelligent and untiring efforts in shaping the law of Florida.

Bob received his B.A. Degree from Dartmouth College He received his Juris Doctorate Degree from Yale Law School. He is admitted to the Florida Bar and to the U.S. Supreme Court.

Bob is one of Dade County's premiere trial lawyers. He has been listed annually since 1987 in the Best Lawyers in America in two categories—Business Litigation and Criminal Law since 2003 and from 2003 he has been listed in Chambers and Partners as one of the top four commercial litigators in Florida. 



Ray was born on August 18, 1976 in Miami, Florida. In addition, the Department of Justice twice awarded Roy the "Director's Award" in 2014 for the prosecution of the men responsible for the murder of U.S. mail carrier Bruce Parton and the multi-million dollar tax fraud and identity theft conspiracy that followed it; and in 2015 for the prosecution of the most prolific serial rape spree in U.S. history.

In 2017, Roy was one of only 90 Americans under the age of 40 selected to participate in Harvard's *Young American Leaders* program. Roy was also one of 15 people selected for the Miami Foundation's Miami Fellowship, which identifies Miami's future leaders and trains them to engage in informed, ethical leadership. In 2013, Roy was inducted into the Miami Country Day School Hall of Fame. In May of 2014, Roy was given the honor of serving as the keynote speaker at Miami Country Day's 75th Anniversary Commencement. Roy has been published in the Wall Street Journal, The National Review, and the ABA's Journal on Criminal Law.

At just 32 years old, Roy became the youngest partner at Podhurst Orseck. Since arriving at the firm, Roy has handled a wide variety of complex international commercial cases and has obtained tens of millions of dollars for the firm's clients.

Commercial Experience:

Roy is Lead counsel on behalf of a nationwide class of plaintiffs who have brought suit against Volkswagen AG and Volkswagen of America for damages arising from a common alignment defect in the 50,000 Volkswagen CC Model vehicles sold in the United States between 2010 and 2017. The lawsuit alleges that the alignment defect causes premature and uneven wear in the class vehicles' tires—a defect known as “tire cupping” that has required each of the 50,000 plaintiffs to spend a great deal more on tire replacements than they otherwise would have. See *Wilson, et al. v. Volkswagen Group of America, Inc., et al.*, Case No. 1:17-vs-23033-RNS (S.D. Fla. Aug. 10, 2017).

Roy also represents two London film financiers in a massive fraud action against Wells Fargo Bank and Wells Fargo Advisors. The lawsuit stems from a fraudulent film financing scheme in which the London financiers became involved at the behest of a number of Wells Fargo bankers who were being paid to lure investors into the scam. The current demand in the case is for \$183 million. See *Vandermolen Film Co. et al., v. Wells Fargo Bank, N.A., et al.*, No.: 2016-CA-0028537-CA-01 (Div. 43) (Fla. Cir. Ct. 2016) (pending).

Roy is Co-lead Trial Counsel in a nationwide antitrust action against the “big four” contact lens manufacturers. The suit alleges that the contact lens manufacturers—and their authorized distributor—illegally conspired to set minimum prices for the resale of disposable contact lenses, in violation of the Sherman Act. See *In re Disposable contact Lens Antitrust Litigation*, No.: 15-md-2626-J-20-JRK (M.D. Fla. 2015) (pending).

Roy also represents a CEO who was fraudulently induced into purchasing a Bombardier aircraft. The lawsuit, which has been filed in state court, asks for \$20.5 million. See *Paradox Int'l Birds, Ltd., v. Bombardier et al.*, No.: 2015-CA-021345(12) (Fla. Cir. Ct. 2015) (pending).

Katz v. Sk Travel et al.; Mr. Altman represents the Estate of Lewis Katz in this Massachusetts aviation accident in which all passengers were killed and in which the damages are estimated to be in the hundreds of millions of dollars.

Wood v. Malaysian Airline System Berhad and Malaysia Airlines Berhad: Mr. Altman represents the Estate of Phillip Wood against Malaysia Airlines in this federal court litigation in the District of Columbia arising from the disappearance of Flight MH370.

Wang et al. v. Gullberg v. IBC Airways, Inc.; Mr. Altman represents the Gullberg Estate against IBC Airways in this Puerto Rico aviation accident that killed everyone onboard.

Allan v. Robinson Helicopter Corp.; Mr. Altman represents the Estate of Ross Allan in this aviation accident litigation in which everyone onboard was killed.

Rey v. Piper Aircraft Co.; Mr. Altman successfully represented the family of one of the decedents in this Colombian aviation accident in which all aboard were killed.

Rueda et al. v. Piper Aircraft Co.; Mr. Altman successfully represented the families of both passengers and both pilots in this Colombian aviation accident, where the passengers were killed and the pilots were badly injured.

Trial Experience:

Roy has tried 30 criminal cases in federal court, including:

United States v. Damion Baston, 13-20914-CR-CMA. Baston, a Jamaican citizen, stole the identity of an American national and, using that identity to travel in and out of the United States, ran a violent international human trafficking business. During the course of almost ten years, Baston tortured, raped, and brutalized more than twenty different women from around the world, and forced these women to prostitute themselves and to give him 100% of their prostitution earnings. Over the course of a decade, Baston earned millions of dollars by enslaving these female victims. After two years of investigation and two weeks of trial, a jury convicted Baston on all 21 counts in the indictment, including 9 counts of money laundering and 3 counts of forced human trafficking, and the Hon. Cecilia M. Altonaga sentenced Baston to 27 years in prison.

United States v. Lavont Flanders and Emerson Callum, 11-20557-CR-KMM, in which Flanders, a former police officer, and Callum, a pornography producer, were accused of luring hundreds of women to South Florida over the course of several years, drugging the women, raping them, and selling the video-footage of the rapes over the Internet and at pornography stores. After years of investigation and two weeks of trial, a jury convicted both defendants on all 22 counts in the indictment, and the Hon. K. Michael Moore sentenced each defendant to 13 consecutive terms of life imprisonment.

United States v. Pikerson Mentor, 11-20351-CR-DLG. Mentor stalked and then murdered Bruce Parton, a U.S. Postal Service letter carrier, in order to steal Mr. Parton's Arrow key, which Mentor and his co-defendants ultimately used to steal the identities of hundreds of victims. With the victims' identities in hand, Mentor and his co-defendants filed hundreds of fraudulent income tax returns with the IRS, and then used Mr. Parton's Arrow key to retrieve the IRS debit cards onto which these tax returns had been deposited. After two weeks of trial, a jury convicted Mentor on all 14 counts in the indictment, including first-degree murder, Hobbs Act robbery, armed carjacking, aggravated identity theft, and access device fraud. At the sentencing hearing, the Hon. Donald L. Graham sentenced Mentor to life imprisonment.

United States v. Marcus Talley and Eddie Talley, Jr., 10-20848-CR-CMA. The Talley brothers founded a domestic terror cell, the Urban Guerilla Syndicate (UGS), whose objective was the downfall of the federal government. Towards this end, the Talley brothers recruited young, often homeless, juvenile boys and initiated them into the UGS. After several weeks of inculcation, the Talley brothers would strap the boys with hoax suicide bombs and send them in to rob commercial banks. The jury convicted both defendants on all counts. The Hon. Cecilia M. Altonaga sentenced Marcus and Eddie Talley to terms of imprisonment of 384 months and 269 months, respectively.

United States v. Quartavious Davis, 10-20896-CR-ASG. Over the course of less than one year, Davis and his five co-defendants committed approximately fifty armed robberies of commercial establishments in South Florida. Some of these robberies turned violent: At a Little Caesar's Pizza on August 7, 2010, one of the defendants repeatedly kicked the store's manager in the face when the manager failed to open the safe quickly enough; at an Advance Auto Parts store on September 15, 2010, Davis fired two shots at a dog that chased him as he fled the store; and at a Wendy's on September 26, 2010, Davis exchanged gunfire with a customer who had a concealed weapons permit and was eating at the Wendy's with his wife. The jury convicted Davis on all counts, and the Hon. Alan S. Gold sentenced Davis to 162 years in prison.

United States v. Thomas Patrick Keelan, 12-20496-CR-JEM. Keelan, a school teacher, initiated and maintained a two-year sexual relationship with one of his 15-year-old male students. After Keelan took a job as the head of the Fine Arts department at an all-boys school in Virginia, he began to travel to South Florida to meet with the victim and to have sex with him. A jury convicted Mr. Keelan on both counts of the indictment, and the Hon. Jose E. Martinez sentenced Keelan to 200 months in prison.

WALTER H. BECKHAM, JR. (1920 - 2011)


At the time of his death, Walter Beckham was Of Counsel to the firm. Along with Aaron Podhurst, Walter Beckham was a founder of our firm, and it is fair to say that few other lawyers in America have as distinguished a record or reputation. He maintained his close association and long relationship with the firm until his death.

In 1941, Walter received his B.A. degree with honors in American History from Emory University. Immediately after graduation, he enlisted in the U.S. Naval Reserve. Walter was on active duty from 1941-1946 in the Pacific Theater of World War II. By the end of the war, he had earned the rank of Lieutenant Commander. Walter continued his service in the U.S. Naval Reserve after the war and retired with the rank of Captain after 28 years.

After leaving active duty in 1946, Walter entered Harvard Law School where he graduated cum laude in 1948 with a L.L.B. degree. While at Harvard, Walter was awarded the James A. Rumrill Scholarship and served as an editor of the *Harvard Law Review* (Vol.61). After graduating from Harvard, Walter returned to Miami and joined the University of Miami faculty as an Associate Professor of Law. In 1949 he was admitted to the Florida Bar as one of its 151 charter members and joined the law firm of Dixon, DeJarnette and Bradford of Miami; he continued on the faculty of the Law School for 2 years, teaching classes at night. In October, 1950, he joined the Law Firm of Nichols, Gaither & Green, making partner in 1952. When the firm dissolved in 1967, Walter became Of Counsel to his then-associate Aaron Podhurst's new firm.

In 1967, Walter also returned to teaching at the University of Miami as a professor of Law. He taught torts, medical-legal trial tactics, and with the assistance of Dean Fred Lewis, he started the school's civil trial advocacy course. While there, he also founded the Medical Institute for Attorneys and served as its Director for 15 years. He retired in 1982 as a Professor Emeritus. Walter and his wife, Ethel, established a scholarship at the University of Miami School of Law – the Walter and Ethel Beckham Scholarship – for students enrolled in the J.D. Program.

During his extraordinary career as a trial attorney, Walter was widely recognized as one of the best trial lawyers in the nation. He was accepted to membership in the American Law Institute, the American College of Trial Lawyers, the Inner Circle of Advocates, and the International Academy of Trial Lawyers, where he served as President. He was a founding member and trustee of the National Board of Trial Advocacy, and served as Chairman respectively of the Aviation Law Section of the American Trial Lawyers Association, the Trial, Tort and Insurance Practice Section of



the American Bar Association, the National Institute for Trial Advocacy and the National Judicial College in Reno, Nevada. Walter is the only non-judge to have served as Chair of the National Judicial College. Walter was also a member and frequent speaker in the House of Delegates of the American Bar Association from 1979 - 1995, during which time he served a four-year term as Secretary of the Association.

Walter received several awards for his contributions to the legal profession: in 1984, he received the Perry Nichols Award from the Academy of Florida Trial Lawyers; in 2004, he was the recipient of the William M. Hoeveler Award from the Center for Ethics & Public Service at the University of Miami School of Law; and in 2009, he received the Legal Legends Award from the Eleventh Judicial Circuit Historical Society. Walter was listed in both *Who's Who in America* and *Who's Who in the World*.
